Principal Report (EJ)

- Review of the <u>School Report Card</u>; a 3-6 grade assessment by the state; negligible achievement dip but growth made appropriate gains, specifically for the lowest 25%.
- Discussion topics include: impact of enrollment in upper grades and school enrollment overall when making comparisons, Brittany Dimick clarifies the by scale score, relationship to upcoming PD and whether or not we can reasonably expect scores to get much beyond this level of achievement (highest at Ensign was a teacher with 87%).
- How can SCC use this data to help? Note that in the assessed categories, science is less of a priority than continued supports for ELA based on scoring
